

It is also my responsibility to submit a <u>Transfer Credit Evaluation Request online</u> so that those transcripts will be evaluated toward my declared degree intent.
- BMCC's SCO will only certify <u>one</u> term for VA benefits without having an official evaluation of the above mentioned transcripts on record. In some circumstances, a second term will be certified if I provide proof that an evaluation is in progress. *If I am unable to order my transcripts, I must submit a signed and dated written statement explaining why I am unable to order transcripts.*
- I will be responsible for paying any tuition and fee overpayment to BMCC which are the result of classes that were certified at BMCC which were previously successfully completed at another institution. I may also be responsible to the VA for any book stipend or housing allowance debts.
- Any inquiries regarding my Transfer Credit Evaluation Request should be directed to the BMCC Service Center at (541)278-5759 or to <u>GetInfo@bluecc.edu</u>.
- Evaluation of my transcripts may take up to eight weeks, so it is important to start this process early. It is my responsibility to notify BMCC's VA SCO when my official transcript evaluation has been completed.
